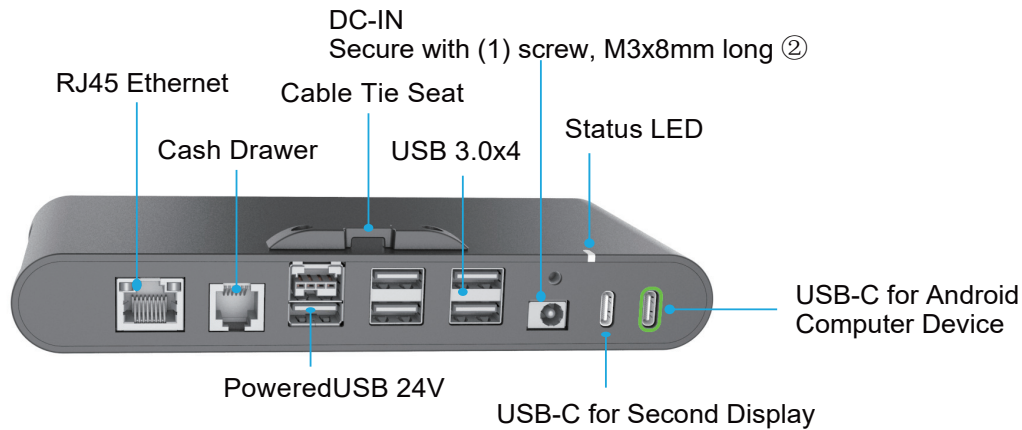

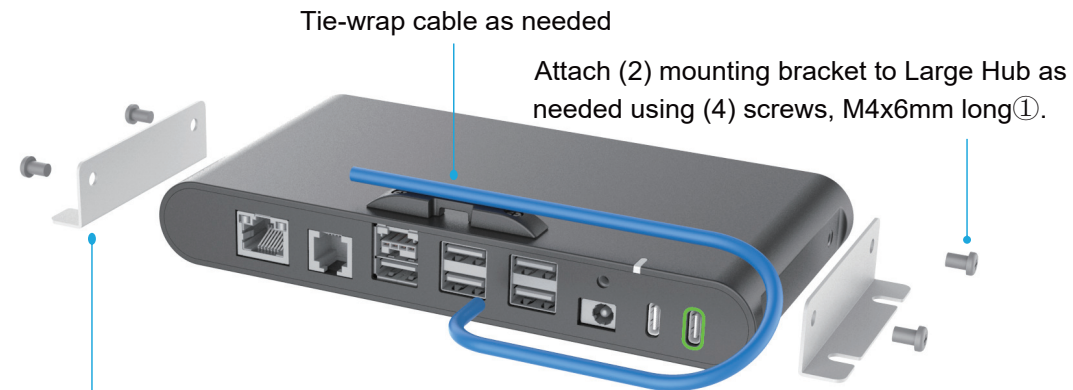

### Large Hub (E815235)



Use (4) screws (max. diameter 4.5mm), not included,  
To mount Large Hub to countertop or other surface.
