# Chapter 1: Introduction

## Product Description

---

Your new touchmonitor combines the reliable performance of Elo Touch Solutions touch products with the latest developments in touchscreen technology and display design. This combination of features ensures a product with stable, drift-free operation, consistent reliability and durability, backed by a 3-year standard warranty.

This open-frame touchmonitor delivers a professional-grade display in a slim, integrated package. It incorporates a pure-glass touchscreen for optimal image quality, a high quality panel and multiple mounting options. Its LED backlight significantly reduces power consumption and eliminates mercury (compared to CCFL-backlit panels). The true-flat edge-to-edge design gives integrators an additional advantage in developing the most aesthetically pleasing products.

## Unpacking the Touchmonitor



- USB cable
- Mounting brackets and screws

## Touchmonitor Connections

---

1. Connect the DVI or VGA video cables between the monitor's DVI/VGA input connectors and your DVI/VGA video source. Tighten the video cable's screws for best performance.
2. Connect the USB touch cable between the monitor's USB connector and your PC's USB port.
3. Connect a 12VDC power supply to the monitor's input power jack.
4. The touchmonitor ships in an ON state, video should be displayed on your monitor already.

# Installing the Touch Technology Software Drivers

---

Some software installation is required for your iTouch Plus touchmonitor to work with your computer. No additional drivers are required for your projected-capacitive touchmonitor, it uses Windows HID drivers.






After accepting the end-user license agreement, the system will initialize to setup installation of drivers.



To complete setup, reboot system by clicking on "Reboot Now" button. Click on "One More Minute" if more time is needed with increments of 1 minute.


Note: System will automatically reboot when “Time left” counter reaches “0”.




For **Windows XP** installations, double-click on the icon from the desktop



Click on “Unzip” button to unzip files.



Select one or more of the drivers to install. Click on “Next”



After accepting the end-user license agreement, the drivers will finish installing.

Reboot your computer after the install is complete.

# Chapter 3: Mounting

## General Mounting Information



The OSD text can be rotated through the OSD menu to better suit your mounting orientation.

## Side Bracket Mount


---

Threaded holes are provided on the back of the monitor for mounting using the provided brackets.



# Rear VESA Mount

A four-hole 100x100mm mounting pattern for M4 screws is provided on the rear of the monitor. The VESA FDMI-compliant counting is coded: VESA MIS-D, 100mmx100mm.



# Chapter 4: Operation

## Power

---

The touchmonitor ships in an ON state.

To turn the touchmonitor on or off, press the touchmonitor power button on the OSD controller once.

The Power Status LED on the OSD controller functions according to the following table:

<b>Touchmonitor status</b>	<b>LED status</b>
OFF	OFF
SLEEP	PULSING
ON	ON

The system consumes low power when in SLEEP and OFF modes. For detailed power consumption specifications, refer to technical specifications on the Elo website <http://www.elotouch.com>

Touching the screen will bring the attached host PC out of SLEEP mode (similar to moving the mouse or pressing a keyboard key).

To improve reliability and reduce wasteful power consumption, disconnect the AC power cable from the monitor when long periods of disuse are planned.

## Touch

---

Your touchmonitor is factory-calibrated and should not need manual calibration (unless the input video is not fully scaled to the native resolution, or the touch experience needs to be calibrated to a specific user).

## iTouch Plus Touchscreen Technology

---

When connected to Windows 7 computers, the touchmonitor can report two simultaneous touches. The iTouch Plus touchscreen can be re-calibrated to your displayed video image, if needed, through the Calibration function in the Elo driver control panel.


The iTouch Plus driver will only support multiple monitor if they are all using the iTouch Plus

touchscreen technology.


To use **multiple iTouch Plus monitors**, plug in monitors to calibrate, double-click on the EloConfig desktop shortcut to run Elo Touchscreen Configuration screen.




Click on “Calibrate Touch Screens...” to calibrate multiple monitors.




Tap monitor screen to identify monitor's identity as shown below.




Identity of the monitor will display. Click on "OK" to proceed to calibration.



Calibrate touch as targets appear on corners of the screen. Follow instructions on screen.



Test touch/drag performance to verify calibration accuracy, “Accept” or “Retry” to redo calibration process.



Run touch calibration on each monitor that is plugged in.

# Projected Capacitive Touch Technology

---

When connected to Windows 7 computers, the touchmonitor can report 4 simultaneous touches. When connected to Windows XP computers, the touchmonitor reports single touches.

No additional drivers are required for this technology to work, it uses Windows HID drivers.

No calibration is required for this technology.

## Gesture Support

---

The iTouch Plus and Projected Capacitive touch technologies enable several gestures that support single and multiple touches. Refer to the Microsoft Website <http://msdn.microsoft.com/en-us/library/dd940543> on the various gestures that are supported in Windows 7.

## Video

---

A display's native resolution is its width and height measured in number of pixels. Generally, for best performance, an image displayed on this monitor will look best when your computer's output resolution matches this monitor's native resolution of 1280 x 1024.

For computer output resolutions at non-native resolutions, the monitor will scale the video to its panel's native resolution. This involves stretching or compressing the input image as needed in the X- and Y-dimensions to fit the display's native resolution. An unavoidable byproduct of the scaling algorithms is a loss of fidelity when the computer's output video image is scaled by the monitor to fit the display. This loss of fidelity is most apparent when viewing feature-rich images at close distances (for example images containing small-font text).


Your touchmonitor will likely not require video adjustments. However, for analog VGA video, variations in video graphic card outputs may require user adjustments through the OSD to optimize the quality of the touchmonitor's displayed image. These adjustments are "remembered" by the touchmonitor. Also, to reduce the need for adjustments for different video mode timings, the monitor correctly scales and displays some of the video industry's most common video timing modes. # On-Screen Display (OSD)

Four OSD buttons are provided on the rear of the monitor to adjust various display parameters.



The same buttons are provided on an optional OSD Control Box which can plug into the RJ-45 connector on the touchmonitor connector panel.



The buttons and their functionality are:

Button	Function when OSD is not displayed:	Function when OSD is displayed:
Menu	Display OSD main menu	Return to previous OSD menu
◀	Display OSD Contrast submenu	Decrease value of selected parameter / select next menu item
▶	Display OSD Brightness submenu	Increase value of selected parameter / select previous menu item
Select	Display Video Source submenu	Select parameter for adjustment / select submenu to enter

Using the OSD buttons controls an on-screen graphical user interface which displays on top of your input video, allowing intuitive adjustment of the following display parameters:

Parameter	Available Adjustment
<b>Brightness</b>	Increase/decrease monitor brightness. Default: maximum
<b>Contrast</b>	Increase/decrease monitor contrast. Default: best gray-shade performance
<b>Clock</b>	Allows fine adjustments of the panel's pixel dot clock. <i>Only applicable for VGA input video</i>
<b>Phase</b>	Allows fine adjustments of the panel's pixel dot clock phase. <i>Only applicable for VGA input video</i>
<b>Auto Adjust</b>	Automatically adjusts the system clock to the input analog VGA video signal, affecting the H-position, V-position, Clock, and Phase menu items. <i>Only applicable for VGA input video</i>
<b>H-position</b>	Moves the image horizontally on the display in single-pixel increments. Default: centered. <i>Only applicable for VGA input video</i>

<b>V-position</b>	Moves the image vertically on the display in single-pixel increments. Default: centered. <i>Only applicable for VGA input video</i>
<b>Aspect Ratio</b>	Switches the scaling method between Full Scaling and Maintain Aspect Ratio. Default: Full Scaling  Full Scaling – scales the X- and Y-dimensions of the input video (up or down as needed) to the display’s native resolution. Fill To Aspect Ratio – Assuming a landscape orientation and an input video with aspect ratio smaller than 1280x1024, scales the Y-dimension of the input video (up or down as needed) to the display’s Y-resolution, and scales the X-dimension to maintain the input video’s aspect ratio (and fills the rest of the display with equal black bars on the left and right).  <i>The touchscreen may need recalibration when switching between Aspect Ratio options.</i>
<b>Sharpness</b>	Adjusts sharpness of the displayed images. Default: no sharpness adjustment <i>Only applicable at non-native input video resolutions</i>
<b>Color Temperature</b>	Selects the display’s color temperature. The available color temperatures are 9300K, 7500K, 6500K, 5500K, and User Defined. If the User Defined option is selected, the user can change the color temperature by changing individual R, G, and B gains on a scale from 0 to 100. Default: User Defined with R, G, and B all set to 100.
<b>OSD H-Position</b>	Adjusts the horizontal location of the OSD menus on the display Default: centered.
<b>OSD V-Position</b>	Adjusts the vertical location of the OSD menus on the display. Default: centered.
<b>OSD Timeout</b>	Adjusts how long a period of OSD button inactivity the touchmonitor will wait before closing the OSD. The adjustable range is between 5 and 60 seconds. Default: 15 seconds
<b>OSD Language</b>	Selects which language the OSD information is displayed in. The available languages are: English, French, Italian, German, Spanish, Simplified Chinese, Traditional Chinese, and Japanese. Default: English.
<b>OSD Rotation</b>	Selects the touchmonitor mounting orientation between Landscape and Portrait to match your physical orientation. This adjusts the rotation of the OSD text Default: Landscape
<b>Recall Defaults</b>	Selecting “Recall Defaults” restores all factory default settings for OSD-adjustable parameters (except OSD Language) and for Preset Video Mode timings.
<b>Video Source</b>	The monitor continually scans for active video on the VGA and DVI connectors. This adjustment selects which of those input ports should be given priority to be displayed. The options are: VGA Priority, DVI Priority Default: DVI Priority

All touchmonitor adjustments made through the OSD are automatically memorized as soon as they are entered. This feature saves you from having to reset your choices every time the

touchmonitor is unplugged or powered off and on. If there is a power failure, the touchmonitor settings will not default to the factory specifications.

## **OSD and Power Lockouts**

---

Press and hold the “Menu” and “Up” buttons for two seconds to enable/disable the OSD Locking feature. When the OSD Locking is enabled, pressing any of the “Menu”, “Up”, “Down”, or “Select” keys will have no effect on the system.

Press and hold the “Menu” and “Down” buttons for two seconds to enable/disable the Power Locking feature. When the Power Locking is enabled, pressing the power switch will have no effect on the system.

## Solutions to Common Problems

---

Problem	Suggested Troubleshooting
The touchmonitor does not respond when turning on the system	Check that the DC power adaptor is properly connected Verify the DC power adaptor is functioning
Monitor display is dim	Use the OSD to increase the brightness. Use the OSD to increase the contrast.
Monitor display is blank	If the Power Status LED is blinking, the monitor or Computer Module may be in SLEEP mode. Press any key / move the mouse / touch the touchscreen to see if the image reappears. Check that the signal source device is turned on. Check that that there are no loose cable connections.
Monitor displays an "Out Of Range" message	Adjust your computer's resolution/timing mode to be within the allowable timing ranges specified for your touchmonitor (see website for specifications)
Monitor display image looks strange	Adjust your computer's resolution/timing mode to be within the allowable timing ranges specified for your touchmonitor (see website for specifications) Use the Auto Adjust function in the OSD
Touch functionality doesn't work	Verify your PC has the latest Elo drivers installed. Perform the calibration routine provided with the latest Elo drivers.
The OSD buttons or power button does not respond when pressed	Check to see if the OSD lock or power lock functions are on

# Chapter 6: Safety & Maintenance

## Safety

---

To avoid risk of electric shock, follow all safety notices and do not disassemble the touchmonitor. They are not user-serviceable.

Ensure that your installation is equipped to maintain the specified environmental conditions listed in the Technical Specifications chapter.

## Care and Handling

---

The following tips will help keep your touchmonitor functioning at an optimal level:

- Disconnect the AC power cable before cleaning.
- To clean the display unit cabinet, use a clean cloth lightly dampened with a mild detergent.
- It is important that your unit remains dry. Do not get liquids on or inside the unit. If liquid does get inside, turn the unit off and have a qualified service technician check it before you power it on again.
- Do not wipe the screen with a cloth or sponge that could scratch the surface.
- To clean the touchscreen, use window or glass cleaner applied to a clean cloth or sponge. Never apply the cleaner directly to the touchscreen. Do not use alcohol (methyl, ethyl or isopropyl), thinner, benzene, or other abrasive cleaners.
- Ensure the environmental temperature and humidity are maintained within specification and do not block ventilation slots.
- Monitors are not designed for outdoors.
