# **Product Description**

The Elo PayPoint Plus register is an all-in-one iPad based cash register that comes equipped with a built-in receipt printer, magnetic stripe reader, barcode reader, cash drawer, and an optional customer facing display. In addition to its built-in peripherals, the system has USB ports (for charging) and serial ports that allow for connectivity of external point of sale devices.





## 1. Magnetic Stripe Reader (MSR)

The register has a built in encryptable magnetic stripe reader. The application provider is responsible for correctly encrypting the reader. When the register is in clerk view, the MSR will be on the left of the register display head. When the register is in customer view, the MSR will be on the right of the register display head.

## 2. iPad Docking Tray

The register is capable of docking an iPad into the display head. The register supports iPad (4<sup>th</sup> Generation), iPad Air, iPad Air 2, iPad (2017), iPad Pro (9.7 and 12.9 inch).

#### 3. Barcode Scanner

The register has a built-in barcode scanner that scans 1-D and 2-D barcodes. When the register is in cashier view, the barcode scanner will be on the right of the register display head.

## 4. iPad Eject Button

The register has a button on the back of the main display head which is used to facilitate the removal of the iPad.

## 5. Customer-Facing Display (North America and China part numbers only)

The register base is equipped with a customer-facing display.

## 6. USB Charging Port

This USB port can be used to charge your mobile device.

### 7. Cash Drawer

The register is equipped with a cash drawer for storing cash, coins and checks.

#### 8. Cash Drawer lock

Use the key that comes with the Elo PayPoint Plus register to lock / unlock the cash register. When the cash drawer is locked, it will not open even when it is commanded to.

# 9. Receipt Printer (built-in)

The register is equipped with a built-in receipt printer that is located on the register base.

#### 10. Cash Drawer Media Slot

The cash drawer is designed with a slot for slipping checks into the cash drawer.

#### 11. Printer Head Release Lever

Pull this lever to release the printer head cover. For more information on how to change printer paper on the register, refer to the Receipt Printer section of this manual.

## 12. Printer Ready Light

The printer ready light will illuminate when the printer is on. For more information please check the Receipt Printer section of this manual.

## 13. Printer Error Light

The printer error light will illuminate when there is a problem with your printer. For more information please check the Receipt Printer section of this manual.

#### 14. Printer Feed Button

Press the printer feed button to feed paper through the printer.

### 15. Printer Power Button

Press the printer power button to power off (and to turn back on) the PayPoint Plus printer. Diagnostic information will be printed when the feed button is pressed and held during printer boot up / power on (i.e. press and hold printer feed button immediately after releasing printer power button).

## 16. iPad Connection Status Light

The iPad connection status light will indicate if the register is able to detect an iPad connection. If the light is illuminated red, no iPad is detected. If the light is illuminated white, an iPad is detected.

#### 17. Bluetooth Connection Reset Button

The Bluetooth connection reset button is used when a new iPad will be connected to the printer. Press and hold the button for 3 seconds to reset the Bluetooth printer connection.

## 18. AC Power port

To power the register, plug one end of the power cable to the register power port, and the other end to the wall.

## 19. Mini USB charging port

This USB port can be used to charge your mobile device.

### 20. RJ45 Serial Port

Use this port to connect a weigh scale or external payment device to your register.

## 21. RJ45 Serial Port

Use this port to connect a weigh scale or external payment device to your register.

# Register Display Head

The Elo PayPoint Plus register display head can be flipped to allow customers to complete purchase transactions by self-swiping payment cards, and to authorize transactions by signing directly onto the iPad.

# **Section 3: Receipt Printer**

# Printer Paper

The register receipt printer operates using heat and not with ink. Printer paper compatible with the Elo PayPoint Plus receipt printer are as follows:

- Type: Thermal Paper
- Paper width: 80 mm (58 mm with paper roll guide installed)
- Printing width: 72mm (50.8mm with paper roll guide installed)
- Roll Diameter (maximum): 80 mm
- Thickness: 0.053 0.085 mm

To change the paper for the Elo PayPoint Plus register receipt printer:


- 1. Ensure that the register display head is flipped away from the receipt printer (in customer-facing view).
- 2. Pull the receipt printer head release lever to release the printer head cover.
- 3. Lift printer head cover.
- 4. Take out the roll of used printer paper and replace with new roll of printer paper. Make sure that the paper is placed and positions in the correct orientation, as shown below.




# Installing Paper Roll Guide

To operate the printer with a 58 mm width receipt paper roll, install paper roll guide as follows:

1. Insert the paper roll guide along the groove of the body Note: Securely insert into the groove marked with " $\Delta$  58"



2. Secure the paper roll guide by pressing on it until it clicks in place.



# Cleaning and Care of Printer

The following tips will help maintain optimal performance of your Elo PayPoint Plus register receipt printer:


- Do not pull any paper that is ejected from the printer.
- Do not touch the printer roller or thermal head surface with bare hands. In the case of contact between printer roller or thermal head and hands, clean the roller and/or thermal head surface with alcohol, as specified in the latter parts of this section herein.
- Note: Contaminating heating elements with any oil or grease (e.g. oil from hands) may shorten the life of the thermal head.
- Turn off printer before performing maintenance on it.

Prior to cleaning the PayPoint Plus register receipt printer, ensure that the register display head is flipped away from the receipt printer (in customerfacing view). Pull the receipt printer head release lever to release printer head cover and access the different printer components listed in Figure 4 above. Guidance on how to clean the printer photo-sensor, thermal head and roller are as follows:

#### 1. Roller (Platen)

It is recommendable to clean the printer roller once every 6 months. To do so:


- a. Use a dry, soft cloth to wipe off any stains from the printer roller.
- b. Clean the entire rubber roller by rotating it.



#### 2. Paper holder and its surrounding area:

It is recommendable to clean the paper holder and its surrounding area once every 6 months. To do so:

a. Use a Nylon brush (or equivalent) to brush off any paper dust or other residues that may have accumulated.




#### 3. Thermal head

It is recommended to clean the printer thermal head once every 6 months. To do so:

- a. Moisten a cotton swab (or soft cloth) with alcohol (ethanol, methanol, or isopropyl alcohol).
- b. Wipe the thermal head with the cotton swab to remove any stain from the thermal head.
- c. Use a dry soft cloth to wipe the thermal head.
- d. Wait to allow the thermal head to dry off, and then shut the printer head cover.

Note: Do not clean the thermal head immediately after printing, as the thermal head may be hot. Be careful of static electricity while cleaning the thermal head. Static electricity can damage the head.



# Clearing Paper Jam

In case of a paper jam, open the paper jam printer door (highlighted in light gray outline below) to clear paper jam. Open paper jam printer door by exerting upward pressure on side rib (highlighted by blue arrow below). If unable to unlatch door using finger force, use an aparatus (e.g. coin) to gently exert an upward lever force to the side latch.

After removing the paper jam door, rotate the knob to clear the paper jam. Once the paper jam is cleared, replace the paper jam door.



Figure 5. In case of paper jam, exert upward pressure on side rib (blue arrow) to open paper jam printer door (light gray)




Figure 6. In case of paper jam, rotate the knob to clear the jam.

# **Section 4: Common Barcode Configurations**

# Out-of-box Settings

Out of the box the default settings of the barcode reader are as follows:

- Presentation Mode
- Illumination always on
  - Red aimer will turn off between reads
  - Most common barcodes enabled
- Beep on successful scan

This section covers procedures to set barcode settings and configurations.

# Illumination Settings



The above setting is the default for the scanner. The white illumination light will be on at all times.



Scanning the above barcode will disable the white illumination light when the scanner is not in use.

# Trigger Mode Settings

Out of the box the default of the scanner will be presentation mode (always on). The reader will be scanning for barcodes at all times. Manual Trigger mode:



PAPHHF.

Scanning the above barcode will enable manual trigger mode. When in this mode, the scanner will need to be activated manually (by software or hardware button) between each scan.

Presentation Mode (default setting):



# **Audio Settings**

Out of the box the scanner will be configured to beep on each successful scan of a barcode. This beep can be enabled or disabled based on your preference.

Beep Disable:



Scanning the above barcode will disable the beeper when a barcode is successfully scanned.

Beep Enable:



Scanning the above barcode will enable the beeper when a barcode is successfully scanned.

# Additional Configurations

#### **Mobile Phone Optimization**

Out of the box the scanner will be optimized to read printed barcodes. If the primary application for your scanner will be reading barcodes from mobile devices, the reader can be configured for this purpose.

#### **Reread Delay**

If your application requires sometimes rereading of the same barcode, your scanner can be adjusted to allow this. The reader is configured to have a delay between each read of the same barcode to prevent multiple scans of the same item. Use a shorter delay when repetitive barcode scanning is required.


# Section 5: Elo PayPoint Framework App

The Elo PayPoint Framework App can be downloaded to an iPad from the App Store.


## Printer

First ensure that the iPad is paired with the PayPoint Plus printer through iOS settings. Then, navigate to the printer tab in the test app.


- Press 'Select printer'
- A pop up menu will appear with a list of detected Bluetooth devices
- Select the 'TSP143IIIBI'.



Test prints can now be ran from the Elo PayPoint Framework App.



Select 'Test Printer' to print out a sample receipt in English




Select 'Print International' to print receipts in other languages. Press 'English' and a drop down menu will appear with a list of supported languages in the Elo PayPoint Framework App.

## Cash Drawer

Select the 'Cash Drawer' tab from the bottom menu to test the PayPoint Plus cash drawer:

• Press 'Open Cash Drawer 1' to open the PayPoint Plus internal cash drawer.


To test an external cash drawer connected to the bottom RJ12 port, select 'Open Cash Drawer 2' to open the external drawer. Note: The external cash drawer port follows Star Micronics TSP100 pin out (CD101A cable for APG drawers)



## Barcode Scanner

Select the 'Barcode' tab from the bottom menu to test the PayPoint Plus barcode scanner:


- When the 'Barcode' tab is selected, the scanner will automatically turn on and be ready to scan barcodes
- 'Presentation Mode' and 'Manual Mode' buttons can also be pressed to change the configuration of the scanner
- When in 'Manual Mode' press the 'Trigger BCR' button to turn the scanner on and read barcodes
- Configuration codes can also be sent directly to the scanner using the 'Send command to barcode reader' text box.
  - Type commands into the window and press 'Send Command'
  - o For a list of supported commands, please refer to Section 4 of this document



# Customer Facing Display

Select the 'CFD' tab from the bottom menu to test the PayPoint Plus customer facing display functionality:


- When the 'CFD' tab is selected, the CFD will automatically turn on and display 'Elo Touch PayPoint'
- Press the 'Clear' button to clear the display and the 'Try Again' button to display 'Elo Touch PayPoint'



# Magnetic Stripe Reader

Select the 'MSR' tab from the bottom menu to test the PayPoint Plus magnetic stripe reader functionality:


- Swipe a magnetic stripe card and the card's information will be displayed in the text box
- Press 'Clear' to clear the information and swipe again if needed



# Weight Scale

Select the 'Weight' tab from the bottom menu to test the PayPoint Plus weight scale support:


- Plug your serial interface weight scale into the COM2 port on the bottom of the PayPoint Plus
- Press 'Select Weight Scale' for a list of supported weight scales and select the scale that is used
- Select 'Set serial port speed' for a list of supported baud rates for the serial port. The baud rate selected will depend on the scale that is used in your setup. For the baud rate supported by your scale, please refer to the user manual for your weight scale
- Place an item on the weight scale and press 'Get Weight'. The weight of the item should be displayed in the text box



## **Serial Port**

Select the 'Serial Port' tab from the bottom menu to test the PayPoint Plus serial port:

- Plug your serial device to the COM1 port on the bottom of the PayPoint Plus
- Select 'Set serial port speed' and set the baud rate for your serial device. The baud rate selected will depend on the device that is used in your setup. For the baud rate supported by your device, please refer to the user manual for your peripheral




- To send data to your serial device:
  - Type text into the 'out date to serial port' window and press the 'Send' button
  - Any response from your serial device will be displayed in the 'In date from serial port' window




# Firmware Updates

Select the 'More' tab from the bottom menu for advanced features supported by PayPoint Plus. From this tab the PayPoint Plus firmware can be updated and the MSR can be configured.

- Download the latest Elo PayPoint Framework app from the app store and press 'Check for update' button to check for a firmware update
- It is recommended to keep firmware updated to the latest available version






### MSR Configuration

From the 'More' tab under 'MSR Configuration' select 'Edit' to begin the MSR configuration process. From this menu the security level and KSID of the PayPoint Plus MSR can be changed.


• Enter you 'Customer Code', 'User ID' and 'Password' in the designated text boxes and press 'Enter' to begin the process of configuring the PayPoint Plus MSR



From the 'MSR Configuration' window, the default KSID and Security Level can be changed:

- Simply select the KSID from the list provided in the drop down menu and press 'Change'. For the KSID settings needed for your application, please contact your software application developer directly.
- To change the security level of the MSR to level 3, press the '3' button next to 'Security Level' and press 'Change'.

### Elo PayPoint Register Care and Handling

The following tips will help maintain optimal performance of your Elo PayPoint Register:

- Disconnect the power cable before cleaning.
- To clean the unit (excluding the iPad), use a soft cotton or microfiber cloth lightly dampened with a mild detergent.
- It is important that your unit remains dry. Do not get liquids on or inside the unit. In the event that liquid does get inside, have a qualified service technician inspect the unit before you power it on again.

## **Section 7: Regulatory Information**

### **Electrical Safety Information**
